Archdiocese of Philadelphia Office for Child and Youth Protection Safe Environment Requirements Checklist

Archdiocesan policy requires all clergy as well as parish and school employees to obtain background checks. Volunteers who have any possible contact with children must also obtain background checks. Required background checks prior to service:

- 1. PA State Police Criminal Record Check
- 2. PA DPW Child Abuse Clearance Check (ChildLine)
- 3. FBI Criminal Background Check (fingerprints)

To be renewed every five (5) years

All clergy as well as staff and volunteers of the Archdiocese who have <u>regular</u> <u>contact</u> with children (once per week or more) must complete the following training requirements:

- 1. Protecting God's Children Awareness Training for Adults, within 90 days of beginning to work with children
- 2. Review of the Technology Addendum (included in Safe Env. training after 7/1/2011)
- 3. Mandated Reporter Training, required for all new clergy, staff and volunteers who began service after December 2011 or who did not take the training in-person

Archdiocesan policy requires that **all employees** and volunteers who may have **any possible contact** with children complete the following background checks and clearances:

Clearances for all clergy and staff and volunteers who have lived in PA < 10 yrs):

- Federal Bureau of Investigation Fingerprint Clearance; go to <u>www.pa.cogentid.com</u> to schedule an appointment and pay for the background check
- Pennsylvania State Police Clearance; can be obtained online at https://epatch.state.pa.us/Home.jsp with results available within a few minutes
- Pennsylvania Child Abuse History Clearance; can be obtained online at https://www.compass.state.pa.us/CWIS

Clearances for Volunteers Living in PA Continuously for 10 years:

- Pennsylvania State Police Clearance
- Pennsylvania Child Abuse History Clearance
- <u>Disclosure Statement application</u> for volunteers to be filed at the place of service (obtain from Safe Env. Coordinator).

Volunteers who have **regular contact** with children (at least one time per week) are required to complete parts one and two of the Safe Environment training within 90 days of beginning their volunteer work.
